## **Conservation and Restoration**

\$1 Million Grant Approved for Conserving Migratory Bird Habitat



Flathead Land Trust and Flathead River to Lake Initiative partners were awarded a North American Wetland Conservation Act (NAWCA) \$1 million grant 1 to

conserve wetlands and agricultural lands and restore wetlands, contingent on continued federal funding for this grant program.

R2L partners will work with several landowners to complete five projects. Projects include important wetlands and surrounding uplands used by thousands of migratory birds on the north shore of Flathead Lake, around the Smith Lake Waterfowl Production Area west of Kalispell, near the Flathead River in Columbia Falls, and near the Mission Mountains and the National Bison Range. Lands protected and restored are part of a network of critical lands that help maintain water quality, healthy river function, abundant fish and wildlife, important agricultural soils, and scenic views.

# *Over 2,000 trees and shrubs planted this summer along the Flathead River*

Aaron Clausen, Flathead River Steward for the *Flathead River to Lake Initiative*, led planting crews and volunteers in implementing restoration projects this Spring on four properties along the Flathead River and the north shore of Flathead Lake, including: MT Fish, Wildlife & Parks' Foys Bend Fisheries Conservation Area and North Shore Wildlife Management Area, the Diamond B Ranch, and a property on Egan Slough. Over 2,000 willows, dogwood, chokecherry and other native riparian plants were planted with the help of professional crews and volunteers, including MT Conservation Corps, Flathead Valley Community College and Salish & Kootenai College faculty and students, and others.

Funding for these projects was provided by MT Fish, Wildlife and Parks, Natural Resources Conservation Service's Environmental Quality Incentives Program (EQIP), and the River Steward Program managed by the Flathead Lakers.
