ONE PROJECT, COMPLETED IN PARTNERSHIP WITH ANOTHER CONSERVATION ORGANIZATION, TRANSFERRED 50 ACRES OF FORESTED LAND ADJACENT TO A LOCAL PARK TO FLATHEAD COUNTY. THE OTHER PROJECT PROTECTED 70 ACRES INCLUDING A THIRD OF A MILE OF THE FLATHEAD RIVER, FORESTED RIPARIAN HABITAT, AND AN IMPORTANT SPRING WITH A PURCHASED CONSERVATION EASEMENT. IN ADDITION, THE 190 ACRES OF CRITICAL WETLANDS PURCHASED IN 2012 WAS TRANSFERRED TO THE U.S. FISH AND WILDLIFE SERVICE SMITH LAKE WATERFOWL PRODUCTION AREA.

AN FLT DISPLAY WAS PRESENTED AT AN AGRICULTURAL
