## Land and Water Conservation

### ***Church Slough conservation project completed***

The Flathead Land Trust recently closed on a conservation easement on an additional 60 acres around Church Slough. This adds to an existing network of conservation easements along the Flathead River and around Church Slough which keep prime agricultural soils in production and protect wetlands and riparian areas for fish, wildlife and water quality. ### ***North Shore Ranch negotiations fail***

Negotiations to purchase the 367-acre property on Flathead Lake's North Shore near Somers failed this April, as the Flathead Land Trust and the North Shore Ranch developers were unable to agree on a price. This leaves the settlement agreement approved by the Flathead County Commissioners and the developers in effect. The settlement allows a 286-lot subdivision on the property, requires an easement on 150 acres for public access, and requires the county to build and pay for subdivision roads and two highway turn lanes on Montana 83. This is a setback for the North Shore conservation vision. However, partners continue to discuss conservation options with other landowners to build a network of conservation of lands critical for clean water, fish, and wildlife, farming and recreation. Thanks to the Flathead Land Trust and Montana Fish, Wildlife & Parks for their efforts to negotiate the purchase of this North Shore property.

### ***Ducks Unlimited and Fish, Wildlife and Parks complete Ninepipe wetland restoration projects***

Ducks Unlimited and Fish, Wildlife and Parks completed restoration of over 100 acres of wetlands in the Ninepipe Wildlife Management Area. In the Mission Valley south of Flathead Lake, the Ninepipe WMA extends over 3,000 acres of pothole wetlands resulting from the last glaciation in a grassland environment. As a result of this high density of small wetlands, the area is critical stopover habitat for a host of waterfowl species that migrate through the valleys of western Montana every fall. The restore wetlands will provide valuable breeding and migration habitat. The MT FWP migratory bird stamp program and a "Glaciated Valleys of Northwest Montana" North American Wetlands Conservation Act grant, secured by River to Lake partners, helped fund the project.

## **Funding and Grants**

### ***Natural Resources Conservation Service (NRCS) accepting Wetlands Reserve Enhancement Program proposals***

NRCS is accepting proposals to improve wetlands conservation. WREP provides assistance to landowners to protect, restore and enhance wetlands and improve wildlife habitat. State and local governments, Indian tribes and nongovernmental organizations are eligible to submit proposals and enter into agreements with NRCS. Proposals must be submitted by May 24. ### ***NRCS accepting proposals for the Agricultural Water Enhancement Program***

NRCS is accepting proposals for water enhancement projects that help farmers conserve surface and ground water and improve water quality. Eligible applicants include Indian Tribes, state and local governments, and nongovernment organizations with experience working with agricultural producers. ### ***Stormwater and Erosion Education Class***

The first Flathead Stormwater Erosion Education Program (SEEP) class will take place in Kalispell May 18 and 19. This class for construction professionals will focus on the fundamentals of erosion and sediment control planning and practices to prevent water pollution. The training includes topics such as site assessment and planning, BMP installation, inspection and maintenance, regulatory requirements, and riparian buffers and bank stabilization.
