A. IN JANUARY, WE PARTNERED WITH CHARLES AND RENATE JAQUETTE TO PLACE THEIR 497-ACRE FARM JUST EAST OF KALISPELL UNDER CONSERVATION EASEMENT. CONTAINING SOME OF THE RICHEST TOPSOIL IN THE VALLEY, THE EASEMENT ADDS TO A GROWING NETWORK OF CONSERVED FARMS IN THE HIGHLY PRODUCTIVE CRESTON AREA. ENCOMPASSING OVER A MILE OF EGAN SLOUGH, THE PROPERTY PROVIDES EXCELLENT BIRD HABITAT AND IS STRATEGICALLY LOCATED FOR BOTH BIRDS AND WILDLIFE AT A LANDSCAPE SCALE.
